Colorado motor vehicle dealers and salespersons are primarily regulated by the Department of Revenue, Auto Industry Division. CADA staff members attend the Motor Vehicle Dealer Board (MVDB) monthly meetings and closely work with the Auto Industry Division.. The nine-member MVDB oversees licensing and supervision of motor vehicle dealers and their sales representatives.
