After the conference report has been approved by both the House and the Senate, the final bill is sent to the President. If the President approves the legislation, he signs it and it becomes law. If the President does not take action for 10 days while Congress is in session, the bill automatically becomes law.

The Federal Legislative Process, or How a Bill Becomes a Law

The chief function of Congress is the making of laws. In addition, the Senate has the function of advising and consenting to treaties and to certain nominations by the President. Under the 25 th Amendment to the Constitution, a vote in each House is required to confirm the President's nomination for Vice-President when there is a vacancy in that office.
